President's Message

Dear Members,

I am indeed privileged to welcome you to the 10thAnnual General Body Meeting of the Global Compact Network India. Today, after this AGM, we will honour the memory of our founding President at the 5thSubirRaha Memorial Lecture. Mr. Raha's efforts were indeed pioneering in developing this Network and making it a cogent platform for 'Corporate India' to enhance its understanding of Human Rights, Labor Standards, Environment and Anti-Corruption and subsequently embed them into their work practices.

During the past one year, Global Compact Network India (GCNI)has meaningfully engaged various stakeholders like Department of Public Enterprises (DPE), Indian Institute of Corporate Affairs (IICA), private sectors e.g. Tata, BMW, Deloitte, International Organisations like various UN bodies including UNDP and Food and Agriculture Organisation (FAO) for high level consultation for the post-2015 development agenda. The past year was full of achievements which would provide us with a strong and effective platform for the coming years.

I am also happy to announce that GCNI has completed a decade of its existence in India. Over the past ten years, through its advocacy programmes, an outreach and key activity, GCNI has achieved numerous milestones and has successfully implemented the Ten Principles of UNGC in the space of corporate India. In 2013 in Bali during the Asia/Oceania meeting, a special emphasis was given on the post 2015 development agenda placing greater responsibility on businesses to contribute more effectively toward a global goal and development agenda. Following up from the Bali Asia/Oceania meeting, GCNI scaled up exponentially not only its programmatic interventions but also its engagements with multi-stakeholders through various partnerships and collaborations with corporates, the Government and civil society.

Allow me to present major activities of GCNI in the past year:

The 9thNational Convention conducted on 14th February 2014, was one of the major events of the past year. The Convention organised at ITC Maurya in New Delhi achieved some path breaking results. Centred around the theme 'Transformational Leadership: Ways to Sustainability and Success,' the conference was inaugurated by Dr. M. Veerappa Moily, the former Union Cabinet Minister, Ministry of Petroleum & Natural Gas and Minister of Environment and Forests, and was attended by about 400 participants including 50 CEOs of large and leading public and private sector companies. It was well covered by leading national and international media. The major highlights of the event were the launch of the 'UN Global Compact-Accenture CEO Study on Sustainability 2013: Insights from CEOs in the Global Compact Network India' and the launch of the Business for Peace (B4P) initiative by India Local Network, second country to launch the initiative after Columbia.

Lecture was organised on the theme 'Expanding Paradigm of Corporate Governance' on 1st July 2013. The lecture was delivered by Mr. U. K. Sinha, Chairman, SEBI. Mr. Sinha in his lecture highlighted that the practice of transparency, effectiveness and ethical operations are key to win trust of the investors. The lecture was attended by more than 300 participants.

The past year also saw the launch of the Bangalore chapter as our fifth local chapter on 2ndApril 2013. The Bangalore chapter was launched by Mr. N. R. Narayana Murthy, Executive Chairman of the Board, Infosys. With five chapters in India, GCNI has pioneered a new model of devolution and effective leadership at the local level and continues to rapidly grow in the country and also in the region.

In implementing the agenda of promoting Human Rights in business, Global Compact Network India organised the 2nd India CEO Forum on Business and Human Rights on the theme titled 'Growth with Dignity, Respect and Accountability', on 2nd April 2013. The event also witnessed the release of the year one report of the India CEO forum on Business and Human Rights. The meeting was inaugurated by Mr. N. R. Narayana Murthy, Chair, India CEO Forum on Business and Human Rights and Executive Chairman of the Board, Infosys and included a panel discussion, which was well represented by experts and professionals from leading think tanks, public and private sector companies and leading academic institutions.

With a focus on promoting Labour principle, Global Compact Network India collaborated with UN Women and CARE India to organise three consultations on Women Empowerment Principles (WEPs) in Mumbai, Bangalore and Chennai respectively on 27th November 2013, 31st January 2013, and 28th February 2014, which emphasized

and Chennai respectively on 27th November 2013, 31st January 2013, and 28th February 2014, which emphasized on promotion and encouragement to women to participate fully in economic life across all sectors. During the year, GCNI also collaborated with Construction Industry Development Council (CIDC) to organise an International Conference on Skill development titled "Harnessing CSR for Skill Development & Employment for Youth" on 20th November and 21st November 2013.

Majority of the activities at GCNI focused its attention on the agenda of sustainability. This year, GCNI conceptualized aunique six-city training on Sustainability and Corporate Governance titled 'Looking Beyond Compliance – Embracing Effective Corporate Governance and Sustainability Practices' in partnership with Deloitte in Mumbai, Bangalore, Hyderabad, Chennai, Delhi and Kolkata. In conduct of these trainings, GCNI collaborated with member companies like YES Bank, Novozymes South Asia Private Limited, NMDC, Vestas, EPIL and Coal India Limited. The training covered more than 75 companies and reached out to approximately 250 executives. I thank member companies for their support and cooperation extended to GCNI in this important endeavor of the Secretariat.

Keeping sustainability at the core of its programmatic interventions, GCNI also organized 'India Sustainability Dialogue: The Ecological Challenge' with BMW Group India on 15th November 2013 with the objective of discussing and understanding the challenges and opportunities that exist to achieve sustainability especially with regard to carbon emissions. On 22nd November 2013, GCNI in collaboration with ITC organised the India Consultation on Sustainable Agriculture Business Principles (SABPs). The feedback from the consultation was presented in Geneva during the Core Advisory Group Meeting of UNGC and was well received.

To provide strategic inputs on the new Companies Act and two per cent CSR clause, GCNI also organised stakeholders' consultations on CSR in Delhi on 23rd September 2013 and in Mumbai on 11th February 2014. GCNI also collaborated with the Planning Commission to organise a consultation on CSR on 27th November 2013. The meeting was chaired by Dr. Syeda Hamid, Member, Planning Commission and was attended by about 100 representatives of major companies, NGOs and the Government.

With the objective of promoting partnership among the key stakeholders, GCNI also collaborated with UNGC and CEO Water Mandate to organise a two-day India Collaboration Lab on 22nd and 23rd October 2013 in New Delhi. The hub initiated social enterprise-corporate partnerships on water and sanitation issues and created a consortium to provide mentoring support to these partnerships.

I am also pleased to inform you that GCNI was awarded a two-year project by the British High Commission's UK Prosperity Fund project on anti-corruption titled 'Strengthen Ethical and Transparent Corporate Governance Practices and Further Responsible Development' in July 2013. As its first activity, an expert group consultation was conducted on 9th October 2013. Two focused group consultation on integrity pact were also organised on 22nd October and 22nd November 2013. On 9th and 10thDecember 2013, the project organised an International Conference on Integrity Pact themed 'Integrity Pact: From Commitment to Compliance' in New Delhi. The second project on Anti-corruption Collective Action Project (CAP) also saw a steady progress. The project organised its 12th Anti-corruption working group meeting on the 10th Principle of UNGC on 9th and 10th April 2013 in New Delhi.

GCNI was also represented at various international conferences organized including the Leaders' Summit, a triennial event organized in New York on 19th and 20th September 2013. The event was inaugurated by H. E Ban Ki-Moon, United Nations Secretary-General. At the Leaders' Summit, GCNI was represented by Dr. Uddesh Kohli, Dr. S. P. S Bakshi, Chairman-cum-Managing Director, Engineering Projects (India) Limited and our former President, Mr. Sudhir Vasudeva, who spoke at the closing plenary of the Summit. Mr. Vasudeva was also part of the panel headed by H.E. Ban Ki-moon, which launched the Business for Peace initiative (B4P). The Leaders' Summit also witnessed the launch of the UNGC- Accenture CEO Study on Sustainability 2013 and subsequently India centeric report on sustainability was launched on 14th February 2014.

GCNI was also represented at the Annual Local Network Forum (ALNF) by its Executive Director Mr. Pooran Chandra Pandey. ALNF was held in Geneva between 21st and 26th April 2013. In February 2014, GCNI also showcased its activities and programmes at the Asia/Oceania Local Network Regional Meeting held in Jakarta between 24th and 26th February 2014. To strengthen partnerships and collaboration at regional levels GCNI conducted a training programme titled 'Looking Beyond Compliance: Embracing Effective Corporate Governance and Sustainability Practices' in Maldives for the Maldivian local network companies. Moreover, GCNI also forged cross network partnership with the Belgium network to hold a consultation on CSR in Mumbai. The consultation was graced by Her Royal Highness Princess Astrid of Belgium and was well covered by national and international media.

Past year, GCNI expanded exponentially in terms of its influence, programmes, activities, and outreach in India as well as globally. It is with great pride and immense satisfaction, I announce that UNGC's Annual report 2013-14 highlights that among the 18 networks of UNGC in the Asia/Oceania region, India network is now ranked one. During the year 2013-14, GCNI has increased its membership, reserves, corpus fund and expanded its presence in the other regions through varied programmatic interventions and advocacy efforts. We are steadily moving towards including academic institutions and industry bodies into our fold and encouraging them to participate effectively in the Global Compact programmes both at national and international levels.

There is a global action towards the formulation of new development agenda with an opportunity as well as responsibility for GCNI to make concerted efforts to provide strategic inputs on the post-2015 development agenda through the strategic planning to build on the gains of the past and maintain momentum on all key issues and parameters. GCNI has already started forging alliances and partnerships to reflect and promote sustainability in all its formats as one of the major areas of its functioning. 



The event also included a panel discussion

focussed on the theme 'Creating a Sustainable Future: From Products to Supply Chain', which was facilitated by Mr. Vishvesh Prabhakar, Managing Director India, Operations & Sustainability Services, Accenture, and included Mr. Andreas Klugescheid, Vice President, Government Affairs, BMW Group, Mr. Kamal Meattle, Chief Executive Officer, Paharpur Business Centre, Mr. Santanu Roy, General Manager- Corporate Planning, GAIL (India) Ltd., Mr. Ganesh Tripathy, Chief Sustainability Officer, Jubilant Life Sciences, and Mr. Srinath Komarina, Assistant Vice President, Yes Bank, as panellists.

New Alliances for Water and Sanitation: India Collaboration Lab

Global Compact Network India in collaboration with UNGC and CEO Water Mandate organised the 'India Collaboration Lab: New Alliances for Water and Sanitation', on 22nd and 23rd October 2013. The event was organised in the background of the increasing water scarcity and poor access to sanitation in India. GCNI is the first country to launch the UNGC's Collaboration Lab Initiative. The meeting convened included representation from wide business sector, social enterprise, civil society and Government, who deliberated to develop partnerships that advance innovative projects in water access, sanitation and hygiene (WASH) and water resources management (WRM). The two-day Collaboration Lab, provided an opportunity for companies to learn about innovations that address their sustainability challenges, and provided social entrepreneurs and NGOs a chance to access resources to scale these innovations. The lab led to development of two new social enterprise-corporate partnerships and facilitated the creation of the India Collaboration Lab Consortium, which aims to track the progress of partnerships and projects, provide mentoring and support for partnerships, and to increase engagement within the WASH issues.











India Consultation on Sustainable Agriculture Business Principles (SABPs)

Global Compact Network India and ITC Limited jointly organised the India Consultation on Sustainable Agriculture Business Principles (SABPs) on 22nd November 2013 at India International Centre, New Delhi. The programme was organised to receive feedback on the "Sustainable Agriculture Business Principles (SABPs)" through structured discussions on what constitutes good practice and policy for global agricultural development in both the private and public sector, determining existing frameworks, indicators and systems, which can form the basis for better partnerships between stakeholders to deliver sustainable agriculture and food security and establishing the voluntary guiding principles that businesses can subscribe to and should apply for working more effectively with the UN and Governments to realise the goals of 'The Future We Want' and the post-2015 development agenda. The agenda setting speech at the event was delivered by Mr. S. Sivakumar, CEO, Agribusiness Division, ITC Limited. The event was moderated by Ms. Poonam Madan, Founder Director, Inesa and was attended by over 70 participants. The feedbacks from the discussions were presented at the Core Advisory Group meeting conducted in Geneva on 2nd December 2013





Embracing Effective Corporate Governance and Sustainability

Global Compact Network India and Deloitte Touche Tohmatsu India Private Limited jointly organised the Six City Sustainability and Corporate training titled 'Looking Beyond Compliance – Embracing Effective Corporate Governance and Sustainability Practices' in Mumbai on 11th September, Bangalore on 13th September, Chennai on 24th September, Hyderabad on 25th September, New Delhi on 27th September 2013 and Kolkata on 30th November 2013. The training was attended by approximately 250 participants in the six cities, which included GCNI members, UNGC signatories and non members, and included insightful presentations by member companies and an informative session by sustainability experts from Deloitte. The training in the 6 cities were hosted by some of the key Global Compact Network India member companies and it's Sustainability Alliance Partners YES Bank in Mumbai, Novozymes in Bangalore, VESTAS in Chennai, NMDC in Hyderabad, Engineering Projects (India) Limited in New Delhi and Coal India Limited in Kolkata.

International Business Forum

The 16th International Business Forum (IBF) was organised between 21st and 25th October 2013 on the theme 'Green and Inclusive Business- Exploring and Developing Markets for Sustainable Growth' in Istanbul, Turkey, by a consortium of German and multilateral development institutions with an interest on the politics of private sector development to impact sustainable economic development and poverty reduction. Focussing on green and inclusive business models, the event aimed at fostering dialogue and knowledge-transfer between businesses, governments and civil society to promote, develop and scale up sustainable business models in developing and emerging countries. The objective of the forum was to identify opportunities where commercial objectives align with development objectives and to explore new ways of cooperation between businesses but also between public and private actors. The IBF also provided the participants an opportunity to take part in training programmes, organised on 21st, 22nd and 25th October 2013, which aimed at increasing an understanding about green and inclusive business.



India Business and Biodiversity Initiative

The Ministry of Environment & Forests (MoEF) organised a Roundtable on Business and Biodiversity (B&B) in partnership with Global Compact Network India and GIZ, on 5 September 2013 in New Delhi, to discuss the scope and structure of "India Business and Biodiversity Initiative".

India Business and Biodiversity Initiative is set up to engage business in achieving the objectives of the UN Convention on Biological Diversity (CBD) and it is a part of Global Partnership for Business and Biodiversity (GPBB) which is the hub for national and international initiatives. The Roundtable was attended by over 50 participants from industry associations, private companies, public sector enterprises, financial institutions, business sustainability initiatives, national and international development and conservation organisations and the MoEF.

Disaster Risk Reduction Equals Resilient Investment

Global Compact Network India, in association with United Nations International Strategy for Disaster Reduction (UNISDR) and HCC organised the India workshop on 'Disaster Risk Resilience' on 27th February 2014 in Mumbai. A day long workshop witnessed participants from the UN, corporate sector, public sector, Government, NGO's and educational institutions. The event included sessions on creating awareness on the Disaster Risk Resilience (DRR) agenda of UNISDR. The event also witnessed a video conferencing session by PWC, UK, on the role of private sector in resilience and a break-out session on engaging the Indian corporate sector collectively engaged in leading DRR Global agenda, incentives or enabling environment for making future to investments more resilient and inclusion of DRR as a part of CSR.









Asia Business Responsibility Summit 2014

Asian Centre for Corporate Governance & Sustainability in collaboration with Global Compact Network India organised Asia Business Responsibility Summit 2014 on 8th January 2014 at Bombay Stock Exchange, International Convention Hall, Mumbai. Mr. Prashant Saran, member SEBI and Judge Mervyn King, Chairman, The International Integrated Reporting Council (IIRC), UK, delivered keynote addresses. Dr. Teodorina Lessidrenska - International Sustainability Consultant from Geneva and several other eminent speakers spoke at the summit. The event also hosted Asian Centre Awards. The objective of these awards was to raise the quality of Corporate Governance and Sustainable Development and to recognise the companies, Industry leaders & Directors, who are doing exemplary work in improving these standards in their respective companies.



Looking Beyond Compliance: Training the UNGC Maldives Local Network

Global Compact Network India in collaboration with Global Compact Network Maldives conducted a training programme titled 'Looking Beyond Compliance: Embracing Effective Corporate Governance and Sustainability Practices' in Maldives for the Maldivian local network companies on 7th December 2013. The programme was designed to provide training on sustainability reporting and Communication of Progress (CoP)

The training was conducted by Mr. Pooran Chandra Pandey, Executive Director, Global Compact Network India and included hands on exercises along with sharing of useful insights and experiences on Sustainability and Corporate Governance. The opening remarks were given by Ms. Azusa Kubota, RR and Coordinator Programmes and Operations, UNDP Maldives. The training programme was divided into three sessions namely; 'Reintroduction to Global Compact Principles', UNGC Management Models and Reporting of Performance on the Universal Principles' and Experience Sharing on CoP by Maldivian Companies'.

International Symposium on Corporate Social Responsibility and Sustainability

Global Compact Network India in collaboration with, Deakin University, Melbourne, Australia jointly organised the 'International Symposium on Corporate Social Responsibility' (IS-CSR) on 12th and 13th December 2013 at the Amrita School of Business, Bangalore. The symposium aimed to foster thought leadership in the highly dynamic and challenging areas of CSR and sustainability. It offered a unique opportunity to explore the meaning and challenges of integrating CSR with the business model, conduct critical evaluation based on case-research evidence including use of international projects for comparing innovative practices and good governance models and explore opportunities for joint project work between industry and academia.

CSR: A Value Proposition for Business

In view of the new 2% CSR clause in the Companies Act 2013, Global Compact Network India (GCNI) in partnership with IICA and Shikhar Organisation for Social Development organised two National CSR Summits on 23rd September 2014 and 11th February 2014 in New Delhi and Mumbai respectively. The key themes discussed at the Summit were, Companies Act 2013, Clause 135: Opportunities and Challenges; Sustainability and Societal Performance: A New Paradigm; and Public Private Partnership Approaches in CSR and Sustainability: Myth or reality. It offered the participants from diverse backgrounds like NGOs, companies, Government, media and the beneficiaries to develop an understanding of Corporate Social Responsibility for sustainable comprehensive prosperity as per the new Companies Act 2013.

Consultation with the Planning Commission on the provisions of the Companies Act 2013

Centered on the theme 'Planning Commission's role in offering a platform to key stakeholders in providing greater clarity on provisions of Rules of Companies Act 2013', Global Compact Network India in collaboration with the Planning Commission organised a round table with the Planning Commission on the provisions of the Companies Act 2013 on 27th November 2013 in New Delhi. The objective of the consultation was to deliberate the role that Planning Commission could play in informing the stakeholders about the various provisions and clauses of the Companies Act 2013.

The initiative of the Planning Commission in form of Civil Society Window / Roundtable on the subject at a time when rules of the Company's Act are being framed assumes greater significance. Such a convening will create a platform for co-operation and partnerships between and among key stakeholder and partners to make the provisions on CSR of the Companies Act a truly social transformational tool. The event was attended by senior advisers from the Planning Commission and key stakeholders, who discussed the key areas where the Planning Commission could take a lead and provide the greater clarity about the various CSR provisions in the Companies Act.

Corporate Social Responsibility: A True Business Case

On the occasion of the Belgian Economic Mission to India, Global Compact Network India in partnership with Global Compact Network Belgium and UNICEF organised a panel discussion titled 'Corporate Social Responsibility: A True Business Case' in Mumbai on 28th November 2013. The event was graced and presided by Her Royal Highness Princess Astrid of Belgium and was attended by over 200 participants. The panel discussed some of the fundamental business issues like 'Evolution of the concept of sustainability', 'Is the new provision of CSR rules in the interest of business and society?, and 'Partnerships and collaboration and investors and capital market'.

Some of the key participants at the event included Dr. Bhaskar Chatterjee, DG & CEO, IICA, Mr. Deepak Arora, CEO, ESSAR Foundation and Mr. Karl Van den Bossche, Consul General of Belgium in Mumbai.

CSR: A Partnered Approach in Implementation

Global Compact Network India in collaboration with XIME and CRY organised a workshop in Bangalore on 15th March 2014 with the objective to address a wide range of possibilities and issues of CSR in terms of corporate actions and the interface of companies with multiple stakeholders, notable non-governmental organisations, business schools and social entrepreneurs.











Anti-Corruption



ACTION PROJECT

The Collective Action Project (CAP), a Siemens Integrity Initiative, is the flagship Project of United Nations Global Compact to promote Principle 10 around the world. CAP was launched in January 2011 simultaneously in India, Brazil, Egypt, Nigeria and South Africa. The aim of the project is to provide a platform on anti-corruption dialogue between private and public sector and incentivize ethical behavior of businesses. The project, in a phased out manner, has taken up certain pressing corruption issues in the Indian context; public procurement, bribery and fraud and its trend in the country, supply chain and embedding ethics & transparency in management studies. The project activities include research study, seminars, workshops, and national stakeholder consultations. The Collective Action Project provides a road map to increase awareness on anticorruption strategies among key stakeholders in India including the government, business, international development agencies and think-tanks.

12th Anticorruption Working Group Meeting on UNGC Principle 10

Taking place in New Delhi, India, the 12th Meeting of the UN Global Compact Working Group on the 10th Principle against Corruption was held in collaboration with the Global Compact Network India on 9-10 April 2013. Approximately 100 executives of international and local businesses, high-level officials from the Government of India, representatives of business organizations, civil society, and academia were convened to discuss best ways to advance the fight against corruption through collective action, and identify challenges and opportunities for businesses to scale up existing anti-corruption corporate

On the first day, participants reflected upon ways in which corporations can contribute to advance anticorruption efforts. Specifically, companies, government officials, and

civil society in India showcased their efforts, and discussed what incentives can be offered to further strengthen existing efforts. Additionally, participants also reviewed the role of collective action in tackling corruption risks in various countries, and Global Compact Local Networks from Germany, India and Nigeria as well as the Egyptian Junior Business Association highlighted their efforts. The meeting also examined a crucial role that Information and Communications Technology (ICT) can play in combating corruption, and showcased how the ICT can be better used to increase access to information and transparency.

Furthermore, Call to Action, a year-long global campaign, was launched during the 12th ACWG Meeting. The Call to Action invites companies to express their support of anticorruption in relation to the UN Post 2015 Development Agenda. The Call to Action urges governments to promote incentive mechanisms for corporate anti-corruption action.

On the second day, working group participants engaged in the interactive session where they discussed some of the challenges in implementing anti-corruption compliance programmes throughout their value chain. The group also identified priorities for the Working Group to advance the anti-corruption and business agenda.

The 12th meeting concluded with a joint session with the World Economic Forum's Partnering Against Corruption Initiative – WEF PACI. The joint session provided an opportunity to update the latest developments that each initiative is focusing on, and reinforce the spirit of collaboration towards the common goal of advancing in the fight against corruption.

3rd Session of the Task Force on Transparency and Anti-corruption at B20 Summit

On Thursday 20th June, 2013 the 3rd Session of the Task Force on Transparency and Anti-Corruption took place within the B20 Summit held in St. Petersburg. Global Compact Network India was a key participant and stakeholder in the deliberation.

Principle 10

Businesses should work against corruption in all its forms, including extortion and bribery.















The major announcement at this session was of the establishment of a Collective Action Hub on Anti-Corruption, a centre of excellence to identify, analyze and exchange best practices and experience in collaborative efforts by companies, government and civil society in opposing corruption.

Other recommendations include more regular and indepth exchanges between business and government, at both national and G20 level on practical ways in which to create a level playing-field and a more attractive environment for investment for example, how to incentivize business to self-report, how to clean up public procurement, and how to raise the standards of compliance in companies' supply chains. State-owned enterprises, export credit agencies and international financialinstitutions have an important contribution to make in achieving these goals thanks to their economic and social influence, especially in emerging and developing markets, both within the G20, and beyond it.

Stakeholder Consultation on Sport Sponsorship and Sport Related Hospitality

In February 2012 the Working Group of UNGC Principle 10 against Corruption established a sub-working group on 'Sport Sponsorship and Sport-related Hospitality'. The sub-working group comprising of international experts has developed a practical guide for companies of all sizes on how to approach sport sponsorship and sport-related hospitality in a transparent and ethical manner. While the Guide is primarily aimed at companies', it provides guidelines to sport entities including federations and players.

The Guide was released for worldwide consultation on July 19, 2013 and the first expert stakeholder consultation was held by Global Compact Network India, in partnership with ONGC Sports on July 31, 2013 in New Delhi. The participants in the consultation represented sports federations, business association, sports head of businesses and players. The special guest in the consultation was Mr. Unmukt Chand, Captain of Indian cricket team (men) which won the U-19 World Cup in 2012. The recommendations of the Consultation will be incorporated in the guide and the final version will be released on December 9, 2013 (Anti-corruption Day) in New York at the 13th Working Group Meeting of the 10th Principle against corruption.

Two-day National Consultation on Supply Chain Transparency and Sustainability in India

Global Compact Network India in partnership with mJunction Services India Limited and Intermodal India organized a two-day national consultation event on Supply Chain Transparency and Sustainability in India at Nehru Centre, Worli on Friday November 15 – Saturday November 16, 2013.

The two day partnership event deliberated on how Indian companies cope with the inefficiencies in supply chain and how they can overcome it for their competitiveness and growth. This unique event had eminent representatives specializing in logistics and specifically on supply chain and reflected on the impact of supply chain corruption in business operations in India.

Eminent representatives like Ms. Beroz Gazdar (Mahendra & Mahendra), Col Arvind Gangoly (Schedulers Inc.), Navikant Srikant (World Bank), Neville Gandhi (Siemens) etc were part of the two day deliberations in Mumbai.

Eminent public sector and private sector companies were a part of this national consultation. The consultation also saw participation by representatives from the small and medium scale enterprises.

One of the key recommendations concluded from consultation was for increasing the cost efficiency in the sector to improve the infrastructure of water transportation and deviate further from road transportation.

The learnings from this two day conference would soon be conceptualized in the upcoming Collective Action Project publication which would explore sector specific issues central to supply chain.

Multi Stakeholder Workshop on the Review Mechanism for the United Nations Convention Against Corruption (UNCAC)

United Nations Office on Drugs and Crime (UNODC) and UNCAC Coalition conducted a four day 'Multi Stakeholder Workshop on the Review Mechanism for the United Nations Convention Against Corruption (UNCAC) from February 24-27, 2014 in Kuala Lumpur, Malaysia. The training was attended by government officials and senior civil society members from Asia Pacific Region. The four day training for the CSOs was divided into two parts, The first part was focused on creating understanding of UNCAC and the legal implication of various provisions. The second part of the training was designed to make the CSOs understand the review mechanism of UNCAC. The training was designed to equip the civil society and other independent anti-corruption experts to prepare a parallel report on the implementation of UNCAC in a particular country and various entry points for the non-government organizations to participate in the review mechanism.

First three days of the training were conducted by the UNODC team comprising of Ms. Mirella Dummar Frahi, Civil Affairs Officer and Team Leader, Mr. M Shervin Majlessi, Regional Anti-Corruption Adviser for Southeast Asia and Pacific, Ms. Elsa Gopala-Krishnan, Crime Prevention Expert and Mr. Nimish Jani, Regional Advisor Anti-Corruption, South Asia. The trainers on the fourth day were Mr. Vincent T. Lazatin, Chair, The United Nations Convention Against Corruption and Mr. Adam Foldes, Advocacy Advisor, Transparency International. Ms. Jot Prakash Kaur, Research Associate, Collective Action Project participated in the training.

Business Ethics and Corporate Transparency: Need for an Emerging Market Discipline

Global Compact Network India in partnership with Alkesh Dinesh Mody Institute of Financial and Management studies, Mumbai University organized a student conference on 'Business Ethics And Corporate Transparency: Need For An Emerging Market Discipline' on March 1, 2014. With a vision to embed ethical values in management studies GCNI along with Mumbai University had announced a call of papers in December 2013. The best papers as a result of the call for papers were given awards during the conference. Ms. Chitra Nair Research Officer from Global Compact Network began the conference mapping the journey of GCNI especially elaborating upon the 10th Principle on Anti-Corruption.

In the backdrop of this paper competition, a business-academia dialogue was organized. Industry experts like Ms. Beroz Gazdar, Senior Vice President, Group Sustainability, Mahindra & Mahindra, Mr. Anthony Lobo, Corporate Social Responsibility Advisor, Tata Consultancy Services (TCS) and S. Chandran, Principal Consultant Business Ethics, TCS, Mr.Sriram Vinjamuri, Head Loan Against Property, Axis Bank, Col Arvind Gangoly, Chief Executive Officer and Founder, Schedulers Inc and academicians like Prof. Ronald Berenbeim, Adjunct Professor, New York University, Prof. Shiv Tripathy, Professor, Mzumbe University, Prof. Subhash Sharma, Director, Indus Business Academy were part of this deliberation on business ethics and management studies.









Anti-Corruption and Applied Ethics in Business Education: PRME Approach

Global Compact Network India(GCNI) along with Principles for Responsible Management Education (PRME) and Indus Business Academy (IBA) conducted a half day workshop on March 3, 2014 at IBA 's Centre for C-School in Bangalore on 'Anti-Corruption and Applied Ethics in Business Education: PRME Approach'. The workshop was attended by eighty faculty members and students of Indus Business Academy.

Prof. Subhash Sharma, Director, Indus Business Academy introduced the topic and gave a brief presentation on business ethics. Prof Shiv Tripathi, Professor Mzumbe University, Tanzania, introduced PRME and its objective. Prof Tripathi said that the mission of PRME is to inspire and champion responsible management education, research and thought leadership globally. Prof Ronald E. Berenbeim, Adjunct Professor, New York University and Member of PRME AC Working group on Anti-Corruption in Management Education conducted a 'brain storming session' with the objective of making the participants familiar with the kind of situations occur in the normal functioning of any organization which are legally appropriate by ethically contested. PRME's bank of business cases was utilized to conduct the session. Ms. Jot Prakash Kaur, Research Associate, GCNI presented the organizations activities pertaining to United Nations Global Compact's (UNGC) Ten Principles engaging the participants in a dialogue wherein the need to make changes in the business school curriculum and inclusion of anti-corruption toolkits was discussed.



STRENGTHEN ETHICAL AND TRANSPARENCT CORPORATE **GOVERNANCE PRACTICES AND** FURTHER RESPONSIBLE DEVELOPMENT PROJECT

Global Compact Network India commenced work on its two-year UK Prosperity Fund supported Anti-Corruption Project titled 'Strengthen Ethical and Transparent Corporate Governance Practices and Further Responsible Development' Project in July 2013. The purpose of the project is to build a national collective action platform for

responsible and sustainable development through informed partnerships with the business community, bureaucrats, civil society and parliamentarians. The project mandates to provide a platform for stakeholders to exchange knowledge and information thus improving upon individual stakeholder practices. In addition the project aims to facilitate dialogue with policymakers by way of providing collective recommendations for bringing a change in the current policy regime on the issue of ethical business conduct and governance.

Expert Group Consultation

The first Expert Group Consultation of this Project was held on 9th October 2013 in New Delhi with the aim of guiding and advising on project implementation. The consultation provided feedback on the Situation Analysis Paper which was prepared to understand the current status of policies and practices of ethical corporate governance in India. The paper was later finalised after incorporating relevant feedback from all stakeholders.

Integrity Pact: Role and Responsibilities of Independent External Monitor

On the recommendation of the Project Steering Committee which gave feedback on Situation Paper and advised the Project to take up the issue of Integrity Pact in the project two focus group discussions were organized on the topic.

The first discussion panel comprising of Independent External Monitors (IEMs) of several Public Sector Enterprises was convened on 22nd October 2013 in New Delhi. Most of the panellists were former Secretaries of Central Government Ministries, Chairman of Industries and currently Independent Directors. To name a few viz. Mr. V. S. Jain Former Chairman, SAIL and Mr. P.R. Balasubramanian, Former CMD, HPCL, Mr. P. K. Banerji, Former Secretary, Interstate Council and Smt. Usha Sahajpal, Former Controller General of Accounts, Ministry of Finance, Mr. V.K. Gupta Former Chief Technical Examiner, CVC, Mr. Pankaj Agarwal, Independent Director, Mazgaon Dock Ltd. and seasoned bureaucrats like Mr. M. N. Buch. These eminent experts shared their views on the implementation of Integrity Pact (IP) in India, its effectiveness and the role played by them in their respective companies.

The focus group meeting explored the inherent challenges in implementation of IPs in India, the unique and pivotal role of Independent External Monitors (IEMs) and also looked at the felt need to expand IPs in other sectors especially the private sector in India

Focus Group Meeting on IP in Private Sector

The second focus group of IPs examined the need and relevance of IP in the private sector. The discussion panel comprised of eminent representatives from companies such as Siemens, Intel, Arcelor Mittal, Deloitte; research think tanks and government representatives. The participants expressed their views on the perception of private sector towards Integrity Pact, lacunae in its implementation, as well as apprehensions and challenges faced by IP in their respective organizations.

While expressing their expressing their reservations concerning IP implementation the private sector representatives agreed in principle on the need for a comprehensive legal mechanism to check corruption in the country and conceded to IP being an important tool in the process towards transparency in business operations in the country. This focus group meeting brought the spotlight back to the non-implementation of IPs in the private sector and examined the possibility of project to project basis where IPs could be utilized.

International Conference -Integrity Pact: From Commitment to Compliance

A two-day International conference on "Integrity Pact: From Commitment to Compliance" was organized by the Global Compact Network India (GCNI) and Transparency International India (TII) on 9-10 December 2013 at India Habitat Centre in New Delhi, India. The Conference was attended by around 150 compliance/vigilance/procurement officers from key public and private sector businesses of India, as well as delegates from United Kingdom, Germany, Rwanda, Malaysia, Bhutan, Bangladesh and Mauritius.

Mr. Sudhir Vasudeva, Chairman and Managing Director of Oil Natural Gas Corporation (ONGC) and President GCNI, while giving the Inaugural Address, said that "ONGC is









proud to be the first Public Sector Undertaking (PSU) to sign the Integrity Pact (IP) and has since implemented it diligently, yielding substantial benefits to them. Specific benefits are greater transparency and integrity between the buyer and seller, improved sense of ethics in ONGC and among the Bidders, reduction in number of frivolous lawsuits and representations and complaints from vendors, speeding up of tender and procurement process and lowering of cost of procurement, reduced political, diplomatic and administrative interference, quick resolution of differences as representations are referred to Independent External Monitors (IEMs) for consideration, reduction in external interventions in matters of contracts and tenders and improvement in the image and general perception about the company." Mr. Vasudeva was firm in his recommendation of IP adoption by other businesses and extended his resolve to share practical experience of ONGC with those who wish to join the IP fraternity.

In his Keynote Address Mr. Pradeep Kumar, Central Vigilance Commissioner of India, highlighted that "In India 28% of the GDP is spent on some form of Public Procurement Contract, which is higher than the total GDP of some states in the country." According to Mr. Kumar "a blend of both curative and preventive measures are needed to control corruption in India and some specific steps that could be used to control corruption are eprocurement, simplification of rules, objective evaluation of offers and prudent management of contracts."

The intensive deliberations over two day specifically explored challenges and came up with recommendations for Implementation Of Integrity Pact, Roles And Responsibility Of Independent External Monitors In IP Compliant PSU's, Transparency In Defence Procurement, Identification Of Red Flags In E-Procurement, Whistleblower Protection, and a Roadmap for Future interventions


Launch of the new Global Compact Network India website








4th Subir Raha Memorial Lecture Report

Veerappa Moily, Union Cabinet Minister, Ministry of Petroleum & Minister Environment & Forests (Additional Charge) in the presence of Mr. Sudhir Vasudeva, President, Global Compact Network India and Chairman & Managing Director, ONGC, Mr. Georg Kell, Executive Director, United Nations Global Compact, New York and Dr. Uddesh Kohli, Senior Adviser, United Nations Global Compact, New York at the 9th National Convention of the Global Compact Network India. The report is the first ever country specific report in the history of UNGC – Accenture CEO Study on Sustainability and presents the perspectives of the Indian Business Leaders on the past, present and future of sustainability business in India and what it will take to harness sustainability as a transformative force in the Indian Economy.

Theoretical Action Actions of Companies Addition

Understanding the Demand and Supply Equations of Corruption and Fraud in India

The second publication of Collective Action Project tilted 'Understanding the demand and supply equations of corruption and fraud' was launched in June 2013. The book captures crucial qualitative and quantitative data on corruption in the private sector, looking closely also at the regulatory legal framework within the country. A sample of over 100 Indian companies indicted by the Serious Fraud Office was used as analytical base for the study. The study was largely based on legal documentations like court orders, charge sheets, fillings with stock exchanges, among others to examine the corruption trends within the private sector businesses in India. The forward to this publication was provided by Georg Kell Executive Director Global Compact Network who affirmed positive faith in the Indian private sector to foster a transparent and sustainable economic environment.

An insight into the corruption and fraud by the private sector in India was well received nationally which also led to deliberation in the Monsoon Session of the Indian parliament.





Collation of activities and its sharing is an important initiatives undertaken by GCNI, to keep its members, patrons and well-wishers updated about its key programmes and activities. To this effect, GCNI launched its new tri-annual newsletter 'nutSHELL' on 10th September 2013. The newsletter provides a brief account of the programmes and the initiatives undertaken by GCNI during the year 2013-2014.

8th National Convention Report

The report collates the proceedings and the outcomes of the 8th National Convention organised on the theme of 'Sustainable Development Goals and India: Accelerating Growth through Innovation, Partnership and Human Development'. The reports in detail captures the proceedings of the Pre-Launch event of the 8th National Convention organised on the theme of Accelerating Millennium Development Goals in India: 2015 And Beyond delivered by Mr. Peter Kenmore, Representative in India, Food and Agricultural Organization (FAO), India and the presentations delivered by top GCNI members at the 8th National Convention.

GCM's Governance

The governance of the Global Compact Network India (GCNI) is led by a Governing Council elected every two years by the General Body, supreme body of the GCNI's governance structure, consisting of GCNI's members. The Governing Council members include President, Vice Presidents representing four regions (North, South, East, West), Treasurer, Secretary, co-opted members and special invitees. The Governing Council is mandated to execute the general policies of the society in conformity with the objects of the MOU, pass and deliberate on organisational resolutions, appoint Chief Executive and determine their power and responsibilities, constitute committees and delegate powers and manages finances. The Governing Council meets in practice once every four months, in a meeting convened by the Secretary.

To support and facilitate the Governing Council there is an Administration Committee. The Administration Committee guides the Secretariat on functional matters and supports it to carry out the Global Compact's mandate in India. The Administration Committee in general meets six times a year or as the need may be to discuss and deliberate on matters affecting the efficiency and effectiveness of the Secretariat and evaluate its work and staff.

To provide the Secretariat with support and guidance, dedicated sub-committees have been constituted on key areas of interventions. These committees, constituted of Global Compact Network India's member organisations and experts, work on key areas of concern, premised on the UNGC principles.

The Secretariat also in its day to day operations is supported and guided by an Operations Committee. The Committee in practice meets whenever matters seeking immediate resolution are brought up by the Secretariat.

To further the Global Compact and carry forward the Global Compact's mandate on the day to day functioning, the Global Compact Network India is supported by a Secretariat headed by an Executive Director.
