Dear Members,

It gives me immense pleasure to welcome you all at the 19th Annual General Body Meeting of UN Global Compact Network India today.

The past two years have transformed the lens through which we see the world today. Be it Covid or the impacts of Climate change or the geopolitical crisis, the world has seen major changes in contemporary times. The other important factors in the context of global challenges include low economic growth, increasing inflation, disruption of supply chains, rising concerns about food and energy security and debt problems.

Today the world stands at the cusp of transformations. At this historical inflection point, how the world responds to setbacks is a choice that will impact what happens now and for generations to come. We cannot really continue with the same old practices especially when we have reached a stage where the aftermath of climate change events is becoming evident, crisis like COVID-19 has befallen the entire world and issues of socio-political and economic areas remain at the center stage of our global as well as national priorities.

The 2030 Agenda stands as our global blueprint for an ideal world. Prioritizing the SDGs is paramount—now more than ever—to swiftly accelerate action towards a sustainable future. Seventeen SDGs, adopted in 2015, marked a paradigm shift in the development agenda. The crucial years of action that we have in our hands today must be utilized in identifying models which have produced results in the achievement of Global Goals. We do not have the luxury of time to develop solutions from scratch and perhaps the Indian model of SDG localisation is relevant. The path of attaining SDGs is long and challenging, but exciting and engaging.

With the 2030 deadline nearing, a global trend towards SDG localization acknowledges sub-national contexts, allowing tailored solutions. India's robust SDG localization

serves as a model, fostering competition among states and yielding superior outcomes. There is considerable confidence in India becoming the third largest economy in the world over the next decade. However, translating this growth into progress on social and human development must be equally valued. One of the areas that we've identified is that our role in India is clearly a two-way partnership. It's not just about bringing international best practices to India. But codifying, recognising the increasing amount of Indian best practices and bringing that to the world.

India has enthusiastically embraced and advanced SDG implementation at the policy level, as demonstrated by the prompt submission of Voluntary National Reviews in 2017 and 2020, along with the adoption of the SDG Index. India's pursuit of Amrit Kaal, envisioning a robust and prosperous nation by 2047, aligns with a vision of equality, quality education, healthcare access, and decent jobs. This echoes the Sustainable Development Goals (SDGs), sharing the commitment to leave no one behind by 2030 through universal development objectives and the importance of modern infrastructure with minimal government interference.

The current trends the world will reach its 2030 promises almost half a century too late in 2078. It says that India stands out because amongst all G20 countries, it has the fastest trend growth from 2015-19, and is moving faster than even lower-middle income countries. On current trends, India is likely to achieve SDGs by 2059.

The age-old proverb "Slow and steady wins the race" has been modified for the 21st century - "Quick and steady wins the race". Contemporary times, the challenges, the issues need faster than ever solutions. However, at the same time, it's extremely important to not lose values & ethics in the zeal of taking faster decisions and quicker implementation.

Wielding the power of platforms like UN GCNI to change the current realities that we face today and to advance the ten UNGC Principles is a powerful way to create and codify meaningful, long-lasting changes.

World Health Day 2022:

'Our Planet - Our Health'



April 7 is celebrated annually in accordance with the World Health Organization's aim to discuss health-related issues and draw attention to specific health issues concerning people across the world. The theme for this year was "Our Planet - Our Health".

UN GCNI under its Health Governance mandate, conducted a dialogue on "Call to Action: Promoting transparency and value-based healthcare through collective action" aligned with the theme "Our Planet—Our Health" of World Health Day 2022. Dr. Somnath Singh, Deputy Director, UN GCNI led the discussion at the event and encouraged the participants to share their views and recommendations to promote transparency and value-based healthcare in India.

Around 200 people from across the sector attended the programme and shared their views and insights on the theme and the best approaches to strengthen Anti-Corruption Collective Action (AC CA) by ensuring transparency and value-based care in the healthcare sector in India.

Cracking the Labour Code

Workshop Series

In 2020, the Indian parliament introduced four "Labour Codes", replacing 29 previous laws on Wages, Industrial Relations, Social Security and Occupational Safety, Health & Working Conditions. The new laws are likely to come into force between 2022 and 2023 and promise to improve social security and wages for workers in the informal sector. Most states have framed rules under the new codes.

UN GCNI, along with Partners for Transparency Foundation India (PTFI) and Alliance for Integrity organized a series of four workshops aiming at - sensitizing MSMEs with regard to changes within the new Labour codes.

The workshops were held as follows:

- April 29, 2022 Implementation & Execution: This session focused on strategies and approaches for the implementation of the laws by the executive branch of government, the practical challenges, and the way forward.
- May 31, 2022 Role of Labour Union: The session focused on the diverse perspectives
 of the labour rights covered under the new code and MSMEs understanding and
 concerns on the law.
- June 24, 2022 Collective Action: The session will deliberate on the perspectives of stakeholders associated with or working on collective action with the MSMEs and their experiences, challenges, and learnings.

The workshops were very vibrant and interactive. It gave a comprehensive 360 degrees understanding of the newly minted Labour Codes and their impact, opportunities, and challenges for the MSME sector in India.

Collective Action Against Maritime Corruption



In order to improve governance and efficiency of ports by promoting corruption prevention practices and Collective Action among local NGOs and across the local logistics value chain. Maritime Anti-Corruption Network (MACN), under Golden Stretch Round of Siemens Integrity Initiative 'Collective Action Against Maritime Corruption' in India, Bangladesh, and Pakistan signed an MoU with UN Global Compact Network India (UN GCNI) in March 2022 to advise the former for the successful implementation of the project and achievement of project deliverables.

Dr. Somnath Singh, Deputy Director, UN GCNI attended the National Launch of the Campaign "Say No to Corruption", organized by MACN on 27th July, 2022 at ITC Grand Maratha, Mumbai and shared his views on how and why collective action by all the stakeholders from Public & Private sectors is necessary to mitigate corruption risks in the Maritime Industry.

He also had in person meetings with private sector stakeholders and DDG, Health Services, Govt of India wherein he encouraged them to provide support to the project to strengthen collective action against maritime corruption in India.

Vigilance Awareness Week-2022



Vigilance awareness is one of the tools of the UN GCNI for increasing public awareness about the perils of corruption and therefore the organization observed Vigilance Awareness Campaign 2022 by conducting 'Vigilance Awareness Campaign: Leaders Commitment Against Corruption' and a Roundtable Discussion on 'Cultivating a culture of Integrity in business leadership practices: Recipe for fast development.'

On 2nd November 2022, UN GCNI, in collaboration with BHEL (Bharat Heavy Electricals Limited-PSU) conducted a roundtable discussion with the CVOs, law & Anti-Corruption experts, and Compliance and Sustainability officers from across the sectors. The CVOs from the Govt and PSUs and 52 experts from diverse sectors shared their insights and views on the theme and provided ways for how India can become a corruption-free nation with a robust vigilance and collective action approach.

The discussion covered topics inter alia- Anti-Corruption laws and their relevance in India, strengthening internal control measures to combat corruption, analyzing intersectional topics of corruption - Digitalization and Gender, Compliance as a measure of anti-corruption, Anti-Fraud and Corruption initiatives/Programs, effective Anti-Bribery strategies, inculcating Integrity and values through education for a corruption-free nation and need for good governance and Collective Action in business.

The roundtable discussion has not only provided a platform to bring public and private sectors together to share their best practices and approaches to combat corruption but also it has helped in creating ownership for fighting corruption with collective action.

International Anti-Corruption Day



Keeping with the tradition of observing International Anti-Corruption Day (IACD 2022), UN Global Compact Network India (UN GCNI) organized a panel discussion titled "Turning the Tide Against Corruption – Industries and Youth Action in Agenda 2030" on 9th December 2022 to create awareness and bring ownership among the industry's leaders and youth for curbing corruption.

Besides this, UN GCNI initiated a signature campaign themed "Taking pledge -- Say No to Corruption" wherein the eminent speakers and the participants from businesses, healthcare organizations, academia, law agencies, and UN organizations took a pledge to say no to corruption. Around 180 participants from across the sectors including over 140 youth from the renowned universities/colleges of India participated in the panel discussion and the signature campaign.

UN GCNI's observance of IACD 2022 marked the start of the efforts to mark the twentieth anniversary of the United Nations Convention Against Corruption (UNCAC) which is reflected by the theme of 2022 International Anti-Corruption Day, 'UNCAC at 20: Uniting the World Against Corruption.'

Human Rights Due Diligence

Unpacking Responsible Business Practices for Start-Ups and MSMEs



There is a growing consensus that the ever-evolving MSMEs and start-up ecosystem have a significant impact on economic growth, employment, and investment opportunities and could be a key enabler in leading the Indian economy toward progress.

Doing business with respect for human rights is the only avenue for a successful business in the long term. The leadership of MSMEs and start-ups must catalyze to take a more rigorous approach to managing human rights impacts. Also, they must support the campaign on mandatory human rights due diligence to establish a level playing field between businesses.

On the occasion of International Human Rights Day, UN GCNI, in partnership with CASCADE and Anbay Legal organized a design workshop titled "Unpacking Responsible Practices for Start-ups and MSMEs" on 10th December 2022. The workshop had a full house with 31 practitioners from Startups and MSMEs. This theme was particularly relevant as the business world continues to face a wide range of challenges in these post-pandemic times. This workshop helped the participating startups and MSMEs to build up their knowledge to take informed steps to address these challenges by training and capacity-building of their staff and vendors and communicating across the setup of their business integrity practices.

- Environmental, Social, Governance (ESG), and Social Compliance norms.
- Prevention of Sexual Harassment (PoSH) & other legislations.

- Secretarial Audit & Standards: Strengthening Corporate Governance.
- Business Integrity and Human Rights.



Note No. 1 Significant Accounting Policies and Notes to Accounts for the year ended 31.03.2023

Background

Global Compact Network India was launched in the year 2000 and formally registered as a Non Profit Entity in the year 2003.

Global Compact Network of India (GCNI/The Society) was registered under the Society Registration Act, 1860 vide registration certificate number S-47567/2003.

The Society has been granted an exemption under section 12A of the Income Tax Act, 1961 vide Registration no. AAAAG3022BE20198 dated 31/05/2021 valid upto A.Y 2026-27.

The Society has registered under FCRA vide Registration No. 231661910 and is valid till 20-12-2027.

The Main object of the Society is to provide a forum to various Indian Society to exchange experiences, network and work together on activities related to Corporate Social Responsibility.

The Main Activity of the Society is to promote sustainable growth beside encouraging good corporate citizenship.

A. Significant Accounting Policies

1. Basis of Accounting:

The Financial Statement have been prepared and presented under the historical cost convention method on the accrual basis of accounting and in accordance with the Accounting Standard issued by the "Institute of Chartered Accountants of India" and other generally accepted accounting principles and practices prevailing (Indian GAAP) in Indian. The accounts have been prepared on the basis of mercantile method of accounting. Membership Fees received has been accounted for. These have been reviewed by the management as applied consistently by GCNI.

2. Use of Estimates

The preparation of Financial Statements are in conformity with Indian GAAP requires management to make estimates and assumptions that affect the reported amount of assets and liabilities at the date of the financial statements. Actual results could differ from those estimates. Any revision to accounting estimates is recognized prospectively. Contingencies are recorded when it is probable that a liability will be incurred, and the amount can be reasonably estimated.

3. Fixed Assets:

Assets are shown at cost less deprecation.

Assets Purchased for Project from Project Funds are charged to specified project Fund respectively and not transferred to Capital Assets and directly charged to Income and Expenditure Account.

4. Depreciation

Depreciation on Fixed Assets is charged on written down value method, at rates prescribed as per Income Tax Act, 1961.

5. Investment

Investments are classified into long term investment and current investment based on intent of management at the time of making the investment. Investments, intended to be held for more than one year are classified as long term investment. Current investments are valued at lower of cost or market value. Long term investments are valued at cost unless there is diminution in value, which is other than temporary in nature. Diminution in value of investment is considered other than temporary based on criteria that include the extent to which the cost exceeds the market value, the duration of the market decline and the financial health of and specific prospect for the issuer. Diminution in on the value of long term investment when considered to be other than temporary is fully provided for and reflected as a provision for diminution in the value of investment.

Investments are stated in the Balance sheet at the realizable value. Income from investments is recognized on an accruals basis and apportioned between funds on the basis of the level of funds invested.

6. Staff Benefits

All staff benefits payable/available within twelve months of rendering the services are classified as short term employee benefits. Benefit such as salaries, wages, telephone reimbursement, leave encashment, LTC, medical insurance, gratuity, etc. are recognized in the Income and Expenditure Account in the period in which the employee rendered service.

Provision for Gratuity, LTA & Leave Encashment has been created as per the applicable provision of the respective acts & financial policy of the Society.

7. Funds

Project Fund: Project Fund received from the funding agencies to carry out the specific project activities.

Subscription Fees: The Society also receives 'subscription fees' which are unrestricted in nature. The excess of income over expenditure during the year, being general purpose in nature is carried forward for use in future periods.

Expenditure: The Society implements its programs for strengthening, training, research and policy development in the area of Capacity Building for members through project conducted by itself or by other partner organization to which it disburses grants.

"Projects Fund held in Society" as advance represent the unspent portion of funds received for project.

8. Grants - Receipt and Utilization

Grants received for specific purposes are carried over to subsequent year till completion of specific purpose and period.

9. Objectives of the Society has followed:

To undertake, research and organise workshops, seminars and conferences for sharing of experiences of respective Society.

To develop network with international and national Society, institutes, etc. for exchange of informations, experiences, study and research work.

To undertake activities/projects aimed at promoting cause of human rights, labour standards, environment and anti-corruption.

10. Currency Conversion

Revenue: Organization has received money in USD and realized in INR.

Expenses: Organization has converted expenses at the average exchange rate for the year as shown in www.oanda.com.
