On February 23rd, 2024, the United Nations Global Compact Network India (UN GCNI) hosted its annual flagship event, the 18th National Convention, in New Delhi. The gathering drew over 700 attendees from corporate, academic, governmental, policymaking, and nonprofit sectors. Serving as the convention's Chief Guest was Shri Hardeep Singh Puri, the Hon'ble Union Minister of Petroleum and Natural Gas and Minister of Housing and Urban Affairs.

Themed "Advancing Sustainable India: Driving Change with Forward Faster 2030," the 18th National Convention aimed to tackle urgent issues and chart a course toward achieving the mid-point targets of the Sustainable Development Goals (SDGs) in the Decade of Action, specifically for India. The convention exemplified collaboration and broad participation from public, private, nonprofit, and governmental stakeholders. Its primary objective was to provide a platform for stakeholders to present their strategies, aspirations, and, crucially, learnings from case studies to facilitate widespread implementation of sustainable innovations across various industries.

Key Takeaways from the Convention:

- 1. The correlation between bold action on the faster forward themes and corporate value creation was comprehensively explored, with discussions involving both speakers and the audience.
- 2. Best practices and innovations, spearheaded by stakeholders, were exchanged to accelerate actions towards global goals. Speakers and disguised guests shared insights and experiences during these exchanges.
- 3.The Target 2030 lens was enhanced through collaborative efforts, aimed at crafting effective solutions for the benefit of all stakeholders. Various sessions were dedicated to refining this approach.
- 4. A singular platform was provided to guide companies on identifying areas where they could make the biggest and fastest impact for 2030. Both speakers and attendees engaged in fruitful discussions to pinpoint these opportunities.
- 5. Collective learning was promoted, and collaborations were fostered to advance Inclusive and Sustainable Development, paving the way for a more sustainable future for all. Through interactive sessions and networking opportunities, participants explored avenues for collective action and shared their commitments to sustainability.
