






Multi-Stakeholders Roundtable Conference on Ethical Business Practices & Integrity in Healthcare Through Collective Action

Initiatives such as anti-corruption coalitions, industry partnerships, and multi-stakeholder initiatives bring together diverse stakeholders with a shared commitment to promoting transparency and integrity. Through collective action, stakeholders can pool resources, leverage their respective strengths, and implement joint strategies to prevent corruption, strengthen governance mechanisms, and promote ethical business practices.

# EXECUTIVE SUMMARY

The Multi-Stakeholders Roundtable Conference on Ethical Business Practices & Integrity in Healthcare Through Collective Action, hosted in collaboration with Kapiti Overseas Private Limited and The Telangana Chamber of Commerce and Industry (FTCCI) on 6th June 2024 at FTCCI, Hyderabad, marked a pivotal gathering of approximately 60-70 healthcare professionals from both the Public and Private sectors. Collective Action is evolving toward a "hybrid co-regulation." Formal regulation efforts at a global and national level have increasingly been complemented by self-regulation efforts stemming from proactive cooperation between business actors from specific sectors. This often includes the participation of civil society, the public sector, corporations, and other organizations. These complementary approaches have reinforced one another, creating positive synergies required from businesses in the context of the 2030 Agenda for Sustainable Development.



Businesses and societies face complex corruption challenges daily around the world, and Collective Action is a key approach to slowing the scale of this issue. Multi-stakeholder partnerships are indispensable to effectively tackle and solve the perennial sustainable development problems outlined in SDG 17. The evolution of Collective Action is also the overall evolution from Compliance to Integrity. It is not only about individually avoiding and mitigating the risks, pitfalls, and likely costs of corruption such as legal or financial, but above all seizing the opportunities and associated benefits of a robust culture of integrity that is fostered and implemented collectively by a committed group of like-minded stakeholders.

Multi-stakeholders' engagement in fighting corruption ultimately helps build a robust governance structure, transparent and ethical business practices, and integrity across the sectors.

# OBJECTIVES

Collective action against corruption is crucial for fostering transparent and accountable governance. When individuals, communities, civil society organizations, and governments unite to combat corruption, they create a formidable force for change. 
# TECHNICAL DISCUSSION: KEY AREAS OF CONCERN IN INDIAN HEALTHCARE
