#### 12th Subir Raha Memorial Lecture

Organized each year by UN GCNI to honor the legacy of Mr. Raha, former CMD of ONGC and the Founder-President of the Global Compact Network India, the lecture features insights from distinguished experts across various fields. This year's theme, "Affordable Green Energy: Navigating Capital and Infrastructural Challenges for Round-the-Clock Renewables," was presented by Dr. Ajay Mathur, Director-General of the International Solar Alliance (ISA). #### Moving from Minimum Wage to Living Wage in India

UN Global Compact Network India, in collaboration with the WageIndicator Foundation and FLAME University, hosted an expert meeting on "Moving from Minimum Wage to Living Wage in India" at FLAME University Campus on August 29–30, 2024. The meeting gathered experts, corporate leaders, trade unions, and international organizations to discuss the complexities of India's wage system, focusing on regional disparities and the need for labor law reforms. Key insights included strategies for raising awareness, building business cases, and fostering social dialogue among stakeholders, all aimed at promoting sustainable wage practices in line with ILO principles. # UN Global Compact: Forward Faster Now | Asia & Oceania Event

The UN Global Compact hosted "Forward Faster Now | Asia & Oceania" on August 5-6, 2024. The event gathered nearly 500 participants, aiming to accelerate sustainable business practices in alignment with the Sustainable Development Goals (SDGs). With only 17% of the SDG targets on track, urgent action is needed. Over 270 companies in the region committed to the Forward Faster initiative, focusing on gender equality, climate action, living wages, finance, and water resilience.

#### **UNGA Week 2024**

The 79th session of the United Nations General Assembly represents a significant milestone in the global endeavor to advance the 17 Sustainable Development Goals (SDGs). The much-anticipated Summit of the Future, which took place during UNGA, highlights the urgent need for enhanced international cooperation to tackle pressing challenges such as climate change, poverty, and inequality, as well as the impacts of ongoing conflicts and global health crises. From September 23 to 27, the UN Department of Global Communications hosted its flagship SDG Media Zone, featuring impactful interviews and dialogues on critical global issues that resonate with people everywhere. Mr. Ratnesh, Executive Director of UN Global Compact Network India, represented the India Network at various sessions, including the Summit of the Future, Climate Week deliberations, the Ocean Coalition, the CMO Forum, the anniversary celebrations of the adoption of the Tenth Principle, and discussions on Business and Human Rights and Global South dialogues.

### **SDG Innovation Accelerator for Young Professionals**



The Final Innovation Camp for the SDG Innovation Program, held on July 25th and 26th, 2024, via Zoom, was a pivotal event where participating teams showcased their SDG-focused pitches and received valuable expert feedback. The camp featured two sessions led by Dr. Sreerupa Sengupta and Dr. Prakash Singh from The Goa Institute of Management. The first session emphasized Solutions Testing and Validation, covering prototyping methods, impact management, and data collection strategies. In the second session, teams presented 7–8 minute pitches detailing the challenges they aimed to solve, the relevant SDGs, and their progress. Expert mentors, including Ms. Sunila Sahasrabudhe, Mr. Kumar Chandan, and Mr. Himanshu Arora, provided insightful feedback to refine the teams' ideas and presentation skills.

This camp was a vital platform for participants to enhance their innovations and align them with SDG objectives. Additionally, we are thrilled to announce that a team from **JSW Cement Limited** has been selected to present their innovative solution on 'Biomass Utilization in the Indian Cement Industry' at the prestigious 'Innovate for Impact' session during the UN Global Compact Leaders' Summit in New York on September 24, 2024, providing them with a significant opportunity to showcase their work to global leaders and industry experts.

#### **Climate Ambition Accelerator**



In July 2024, the UN Global Compact Network India organized two sessions on GHG Accounting, focusing on Scopes 1, 2, and 3 emissions, led by experts from WSP. These sessions emphasized the significance of GHG emissions measurement and reporting using the Greenhouse Gas Protocol, facilitating participant engagement through Q&A segments. A GHG Practical Exercise followed, where teams calculated emissions for Java House Coffee Co. based on operational data. On September 6, the SBTi Expert Session highlighted the urgent need for corporate climate commitments, introducing new SBTi standards to aid businesses in setting targets. Additionally, on September 10 and 11, WSP Australia experts conducted a session on managing GHG emissions, discussing actionable strategies to reduce emissions across all scopes. These initiatives underscore the importance of science-based targets in advancing sustainability and achieving a net-zero future.


