## BACKGROUND

business, Education, public service, and civil society. Corruption often compromises the integrity, efficiency, and trust in these sectors, creating a need for concerted efforts towards transparency, ethics, and accountability.

With its core values of critical inquiry and evidence-based practices, Academia plays an essential role in bridging sectoral gaps, fostering cross-disciplinary collaborations, and influencing policy. This session will examine how academic institutions can lead and facilitate collective action to strengthen anti-corruption frameworks and promote governance and ethical standards. Through knowledge-sharing, interactive workshops, and case studies, the session seeks to inspire all sectors to take active steps towards a corruption-free environment, contributing to SDG 16 and the broader Sustainable Development Goals.

## RATIONALE

‘Collective action is a powerful strategy to tackle corruption, but it requires the engagement of all sectors—corporate, NGOs, healthcare, academia, MSMEs, and government. This session will provide a platform for understanding the unique and shared governance challenges across these sectors and how collaboration can enhance institutional resilience and integrity. Academia is uniquely positioned to convene these stakeholders, offering evidence-based insights, facilitating dialogue, and fostering partnerships that can lead to meaningful change in governance practices.

## OBJECTIVES

- Identify Governance Challenges: Examine governance issues in corporate, academia, healthcare, and MSMEs, highlighting how corruption undermines economic growth, public trust, and social equity.
- Promote Ethical Standards and Practices: Discuss strategies for instilling ethical practices and integrity within institutions, exploring initiatives that have proven effective across sectors.
- Showcase Global Best Practices: Present case studies and best practices globally to showcase successful models of transparency, governance, and anti-corruption.
- Policy and Action Recommendations: Formulate actionable recommendations for policymakers, sector leaders, and regulators to strengthen anti-corruption frameworks.
- Foster Multi-Sector Collaboration: Provide a collaborative environment for stakeholders from academia, government, business, and civil society to share insights, align objectives, and build partnerships.
