# INTRODUCTION

On December 9, 2024, the International Anti-Corruption Day (IACD) marked a watershed moment in India's fight against corruption. Organized by the UN Global Compact Network India (UN GCNI) in collaboration with the PHD Chamber of Commerce and Industry (PHDCCI) and AQUAKRAFT, the event convened over 200 participants, including leaders from healthcare organizations, pharmaceuticals, businesses, NGOs, and academia. Held under the theme "Empowering Change through Integrity: Cross-Sector Collaboration Against Corruption," this event underscored a collective action approach to promote transparency and ethics, particularly in the healthcare sector.
