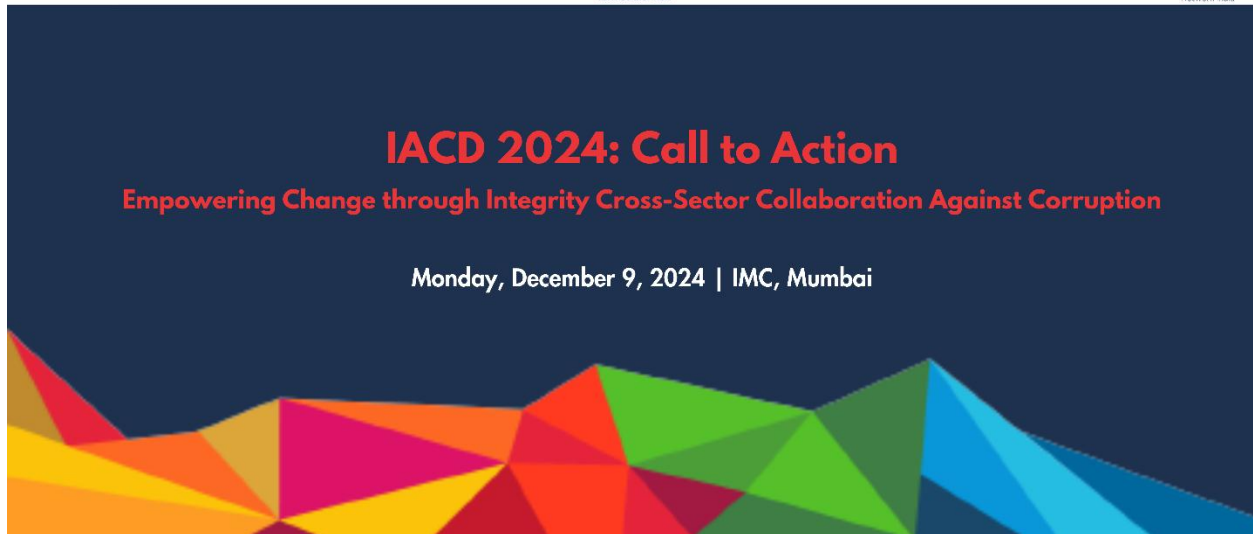
The session brought together leaders from academia, business, healthcare, NGOs, and media to advance Sustainable Development Goal 16 – fostering peace, justice, and strong institutions.

The discussions spotlighted key themes like transparency, ethical leadership, and accountability, addressing corruption challenges through innovation, collaboration, and collective action.

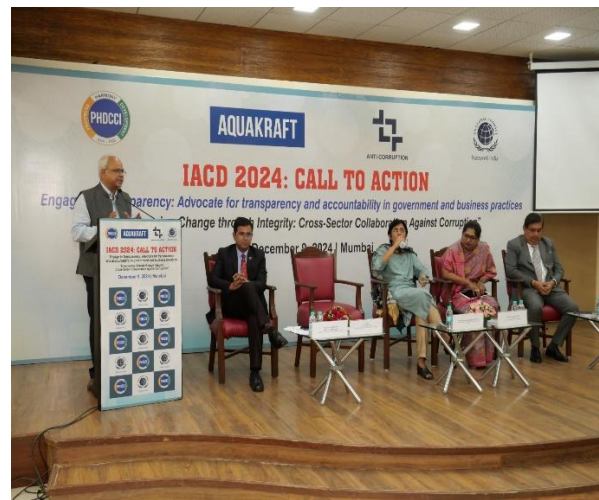


International Anti-Corruption Day 2024: Call to Action

Engage in Transparency: Advocate for transparency and accountability in government and business practices.



International Anti-Corruption Day (IACD), observed annually on December 9, is a global call to action against corruption, urging all sectors of society to embrace transparency, ethics, and accountability. This year, UN Global Compact Network India (UN GCNI) aims to deepen its focus on reducing corruption across key sectors: healthcare, micro, small, and medium enterprises (MSME), academia, and business. This observance aligns with Sustainable Development Goal (SDG) 16.5, which aims to eliminate corruption in all forms and sectors.





Corruption impacts every facet of society and disproportionately affects essential services and vulnerable industries. The healthcare sector is compromised when resources meant for public welfare are misappropriated; MSMEs, the backbone of many economies, suffer when corruption raises the cost of doing business. As a builder of future leaders, Academia must maintain integrity to foster a culture of ethics. Lastly, business ethics drive sustainability and trust, which are fundamental for growth. The 2024 observance seeks to unite stakeholders from these sectors to discuss and implement actionable solutions for a transparent, corruption-free society.

Dr. Pradnya Saravade (Rtd. IPS), Independent Director and Former Director General of Police (Maharashtra), the Chief Guest for the event, said, Corruption is not merely an issue of individual malfeasance but a systemic challenge that demands multi-stakeholder collaboration. Governments, businesses, civil society, academic institutions, and individuals all have roles to play in creating a culture of integrity.

DECLARATION:

After the symposium, UN GCNI and NLUD came up with a declaration. The declaration, adopted underscores a unified vision to tackle corruption and reinforce transparency, accountability, and integrity across India's sociopolitical and economic systems.

Acknowledgments:

The declaration begins by recognizing critical issues and opportunities:

1. **Corruption's Impact:** Acknowledging that corruption significantly threatens India's democratic institutions, economic growth, and social equity.
2. **The Need for Strong Systems:** Emphasizing the importance of robust, transparent, and accountable systems that prioritize integrity and public trust across all sectors.
3. **Role of Education and Technology:** Highlighting the critical role of education, advocacy, and innovative technologies in fostering ethical governance and active citizen participation.

Proclamations:

The declaration makes the following proclamations:

1. **Governance Principles:** Integrity, accountability, and transparency must form the foundation of governance to ensure equitable development and social justice in India.
2. **Shared Responsibility:** Combating corruption requires collective engagement from governments, industries, academia, and civil society.
3. **Resilient Frameworks:** Establishing a robust framework rooted in legal, institutional, and technological reforms is essential for building public trust and creating systems resistant to corruption.

RESOLUTIONS

The declaration outlines eight resolutions to address corruption and promote good governance:

1. Strengthen legal and institutional frameworks to deter corruption.
2. Promote ethical leadership in governance and professional practices.
3. Safeguard whistleblowers and ensure support for victims of corruption.
4. Leverage technology to enhance transparency and accountability.
5. Empower citizens through education and encourage proactive engagement.
6. Foster collaboration among governments, industries, academia, and civil society.
7. Integrate ethics and integrity into educational curricula and professional training.
8. Promote cultural and social transformation to establish a corruption-resistant society.

This declaration signifies hope and unity in the fight against corruption, paving the way for a brighter and more equitable future for India. It reflects a collective determination to create a society where transparency and accountability are central to governance, fostering trust and equity among all citizens.

The adoption of this declaration marks a significant milestone in the ongoing efforts to address corruption. The National Symposium concluded with a shared resolve to implement these resolutions and drive impactful change at every level of governance. Organizers pledged to sustain the momentum through follow-up initiatives, ensuring that the outcomes of this symposium translate into tangible reforms and actions.
